

Terms and Conditions – RACQ International Women’s Day Fun Run 2021

Collect 7 of 9 Badges to win promotion

1. Entry into the RACQ International Womens' Day Fun Run 2021 (IWDFR) **Collect seven (7) of nine (9) Badges to win** (“**Promotion**”) is deemed to be an acceptance of these Conditions of Entry. Information on how to enter the Promotion and prizes associated with the Promotion form part of these Conditions of Entry.
2. Entries for the Promotion commence at 00:01hrs AEST Monday 4 January 2021 and close at 11:59hrs AEST Sunday 7 March 2021 (“**Promotion Period**”).
3. Entry is open to all IWDFR participants (“**Entrants**”).
4. Directors, officers, management, employees and other staff (and the immediate families of directors, officers, management, employees and other staff) of Mater Foundation and their related bodies corporate and agents are ineligible to enter.
5. Directors, officers, management, employees and other staff (and the immediate families of directors, officers, management, employees and other staff) of The Royal Automobile Club of Queensland Limited (RACQ) and their related bodies corporate and agents are ineligible to enter.
6. The Promoter reserves the right in their sole discretion to disqualify any individual who the Promoter have reason to believe breached any of these conditions or engaged in any unlawful or otherwise improper misconduct calculated to jeopardise the fair and proper conduct of the competition. 8. Each valid entry received during the Promotion Period will be placed in the related Major Prize Draw.
9. There is a total of one major prize winner (“**Major Prize Winner**”).

13. The Major Prize Winner will be advised within five (5) business days of the draw and their name may be published on www.womensdayfunrun.com.au
14. The Major Prize Winner will receive their prize by mail.
15. Entries must be received by the Promoters within the Promotion Period. Entries are deemed to be received upon a verified donation being received to a participants fundraising page during the promotion period.

 - 16.1. The value of the prize pool is accurate at the date of commencement of the Promotion Period. The Promoter accepts no responsibility for any variation in the value of the Prize after that date.
 - 16.2. The Prize cannot be transferred, exchanged or redeemed for cash.
 - 16.3. Each prize needs to be activated within six (6) months of the activation date printed on the card and the card expires twelve 12 months from the date printed on the card.
 - 16.4. The Promoter’s decision is final and no correspondence will be entered into, including in the event of a dispute.
 - 16.5. If a purchase exceeds the face value of the voucher, you must make up the difference with another payment method; you are liable for all transactions on your voucher.

18.1. If any act or omission, event or circumstance occurs which is beyond the reasonable control of the Promoter and which prevents the Promoter from complying with these Conditions of Entry, the Promoter will not be liable for any failure to perform or any delay in performing its obligations.

18.2. The Promoter reserves the right, subject to any applicable law, to cancel, terminate, modify or suspend the Promotion.

18.3. The Promoter will not be liable for any loss or damage whatsoever which is suffered, including but not limited to indirect or consequential loss, or for any personal injury suffered or sustained as a result of receiving, taking or using any Prize except for any liability which cannot be excluded by law.
